Edited Competition Rules

1. Alberta Deans of Business Case Competition

- Can use Internet, cannot phone a friend
- No audio allowed in presentations
- Each team member must present part of the overall case
- Max of 15 minutes for presentation
- 5 minutes questions
- **What is the focus of the oral presentation?**

The focus is on communicating how and why your proposal will solve the most important or urgent problems you have discovered in the case material. You must convince a panel of judges of your solution's ethicalness, suitability and chances of success.

2. CPA Alberta Business Challenge Competition

- No access to the Internet
- Presentation max 12 minutes
- Each team member must be a part of the presentation and teams will be awarded additional marks if all team members participate in answering questions.
- Business attire is required for presentations.
- PowerPoint Presentation Rules
 1. There is no limit to the number of slides that may be used.
 2. The use of pictures, video clips or sound clips are not permitted.
 3. Competitors are permitted to use the Drawing toolbar and Smart Art i.e. circles, lines, boxes, text boxes, arrows, etc.
